8.I. Oath Of Office And Pinning Of New Police Officer

*New Police Officer, Jordan Williams was sworn in by City Clerk, Kamy Kulow.*

8.II. Community Improvement District (CID) Discussion

*Cory Collins with Hush Blackwell, representative for the developer, addressed Council advising that the Community Improvement District (CID) would apply to the Lyla Corners and Silver Maple Estates developments that are currently in Tax Increment Financing programs. The sales tax within the CID would increase in order for the developer to more quickly recoup development costs. David Martin with Gilmore & Bell, the City's economic development counsel, attended via phone and advised that a 1% tax increase in the CID would help pay off the TIF sooner. He further advised that the City can require City staff members to sit on the CID board and can stipulate whether CID dollars run through the City prior to the developer receiving them. City Council advised Mr. Collins that if the developer should choose to move forward with an official request for the CID, they would review and consider an official proposal.*

8.III. Discussion - Create Here

*James Pettit and Shannon Walker addressed Council explaining what Create Here is. It is a community group that started originally in the GRO program. Revamped to meet the specific needs of Aurora and surrounding communities. Looking for people to start or grow into their own business in the Aurora community. Local businesses that have been here less than three years have given their experiences and knowledge to help in knowing the steps to get started, what to expect to help the Create Here group gain knowledge. They have made a resource guide to help get started.*

8.V. First Reading Of Ordinance 2022-3253-Amending Section 115.030 "Officer's Oath-Bond"

*City Manager, Jon Holmes addressed Council about Amending Section 115.030 "Officer's Oath-Bond", stating that it hasn't been updated since 1996. The way purchases were made back then were by using store credit and getting invoiced once a month but since it has been streamlined and department heads have purchasing cards, it is much easier now to have receipts for everything that is bought at the time. By giving the department heads access to money, he feels they need to be bonded as well. Requesting the bond amounts go from and added as follows:*

*City Manager, Assistant City Manager, City Clerk, Treasurer, Collector from \$20k bond to \$50k bond*

*City Mayor from \$10k bond to \$25k bond*

*Add Department Heads and other City Staff as needed to \$50k bond*
