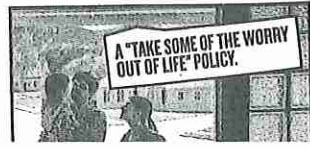
"Myself, Eric and Kyle ... are going to remain here and continue to operate the mid-continent region of the combined companies," Wilmoth said.
