

## RESOLUTION 2021-1798

### **A RESOLUTION OF THE CITY OF AURORA, MISSOURI AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE A CONTRACT WITH BLEVINS ASPHALT FOR THE ASPHALT OVERLAY OF DESIGNATED CITY STREETS AND FOR THE PAVEMENT OVERLAY OF MAPLE PARK CEMETERY AND BALDWIN PARK**

**WHEREAS**, the City of Aurora, Missouri has determined the need to enter into an agreement for asphalt overlay of the city streets of Highland Street, Hudson Street, Pearl Street, Plumb Street, Elm Street, Tyler Street, Maple Park Cemetery and Baldwin Park as designated by the Public Works Superintendent, Jason Jordan; and

**WHEREAS**, the City of Aurora City Council has budgeted adequate resources for annual paving projects as determined by the Public Works Superintendent, Jason Jordan; and

**WHEREAS**, on April 14, 2020 the City of Aurora accepted a bid from Blevins Asphalt at the rate of \$60.40 per ton; and

**WHEREAS**, on March 16, 2021 Blevins Asphalt made an offer to the City of Aurora to extend the existing contract for one additional year at the current contract rates; and

**WHEREAS**, the contract year would begin on March 17, 2021 and terminate on June 30, 2021 with an option of extension of work after June 30, 2021 to include an increase of asphalt prices based on the current MoDOT asphalt index; and

**WHEREAS**, it has been determined that accepting the contract extension from Blevins Asphalt will reduce some the city's costs for paving and Public Works Superintendent, Jason Jordan, is therefore recommending city accept the contract extension offered by Blevins Asphalt in the amount of \$235,112.40; and

### **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AURORA, AS FOLLOWS:**

**Section 1:** That the City Manager is hereby directed and authorized to execute and agreement with Blevins Asphalt for the asphalt overlay of city streets in the amount of \$163,986.00; and

**Section 2:** That the City Manager is hereby directed and authorized to execute and agreement with Blevins Asphalt for the asphalt overlay of cemetery streets at Maple Park Cemetery in the amount of \$39,578.40; and

**Section 3:** That the City Manager is hereby directed and authorized to execute and agreement with Blevins Asphalt for the asphalt overlay of park streets and the dog park parking lot at Baldwin Park in the amount of \$31,548.00.
