LIST OF BOARDS AND COMMISSIONS

1. Park Board – Aurora City Code 150.010 – 150.060

- Six Members
- 3 year terms
- Requirements: Four must be Residents of Aurora
- Remaining Two Members that reside outside of the City of Aurora are required to be employed or own a business within the City Limits.

2. Airport Board – Aurora City Code 150.070 – 150.120

- Seven Members
- Requirements:
 - Four Members must be Residents of Aurora – Serve 3 Year Terms
 - Three have no restrictions regarding residency – Serve 2 Year Terms

3. Hospital Board of Trustees – Aurora City Code 235.010 – 235.160

- Seven Trustees
- Requirements:
 - Five Members must be residents of Aurora – Serve 4 Year Term
 - Two Members must be residents of the State of Missouri – Serve 4 Year Term

4. Board of Zoning Adjustment – Aurora City Code 400.470 – 400.500

- Five Members
- Requirements: All five Members must be Residents of Aurora – Serve 5 Year Term

5. Planning and Zoning Commission – Aurora City Code 405.010 – 405.070

- Seven Members
- Requirements: All seven Members must be residents of Aurora – Serve 4 Year Term

6. Building Board of Appeals – Aurora City Code 500.030

- Five Members
- The members are not required to be a resident of Aurora – Serve 3 Year Terms
- Requirements: "The building board of appeals shall consist of individuals who are design professionals or who are qualified, by education, experience, or training in the various disciplines or professions associated with the building industry"
